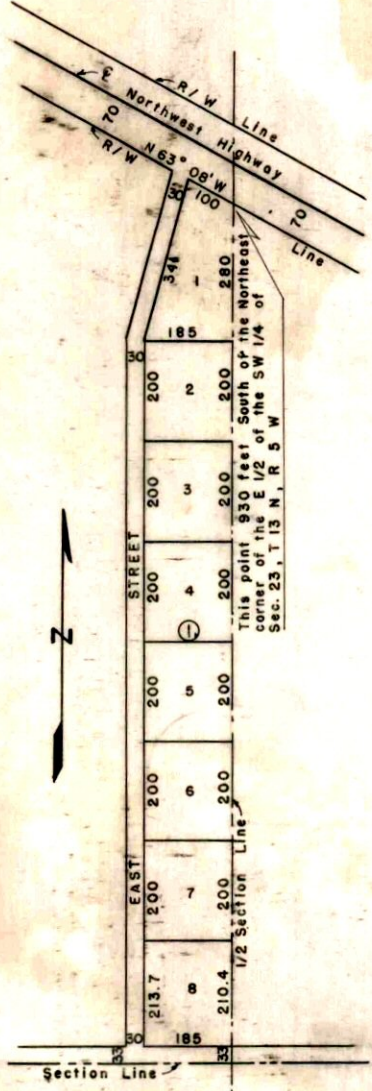

KNOW ALL MEN BY THESE PRESENTS:

I, Helen March, do hereby certify that I am the duly elected, qualified and acting County Treasurer of Canadian County, Oklahoma, that the tax records of said County show all taxes are paid for the year 1956 and prior years on the following described property, platted as Davis Heights Sub-Division No. 1 a part of the E 1/2 SW 1/4 of Section 23, Township 13 North, Range 5 West of the Indian Meridian, Canadian County, Oklahoma. Dated this 17th day of January, 1957.
