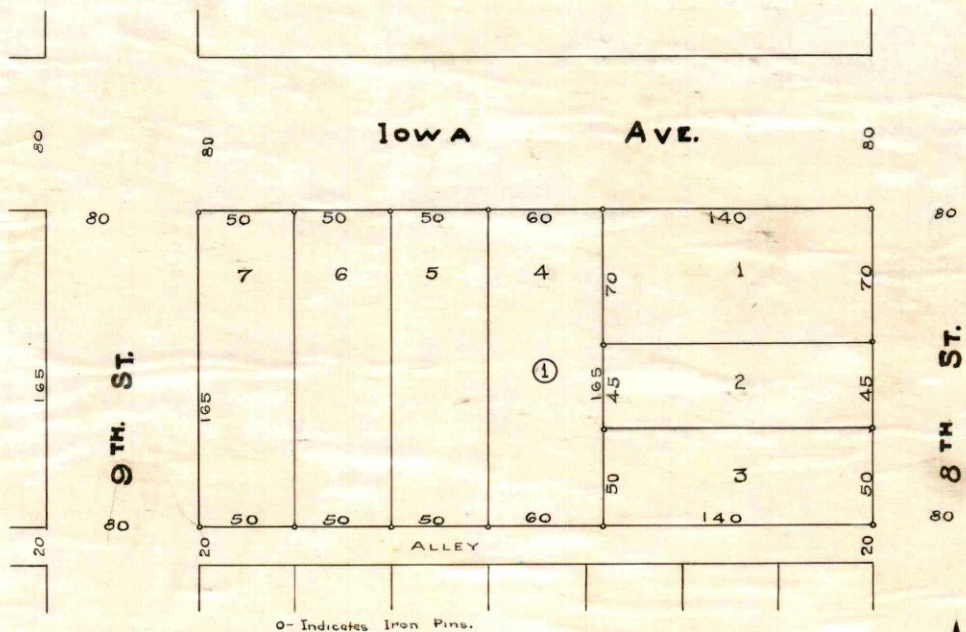


HILL CREST ADDITION OKARCHE OKLAHOMA
