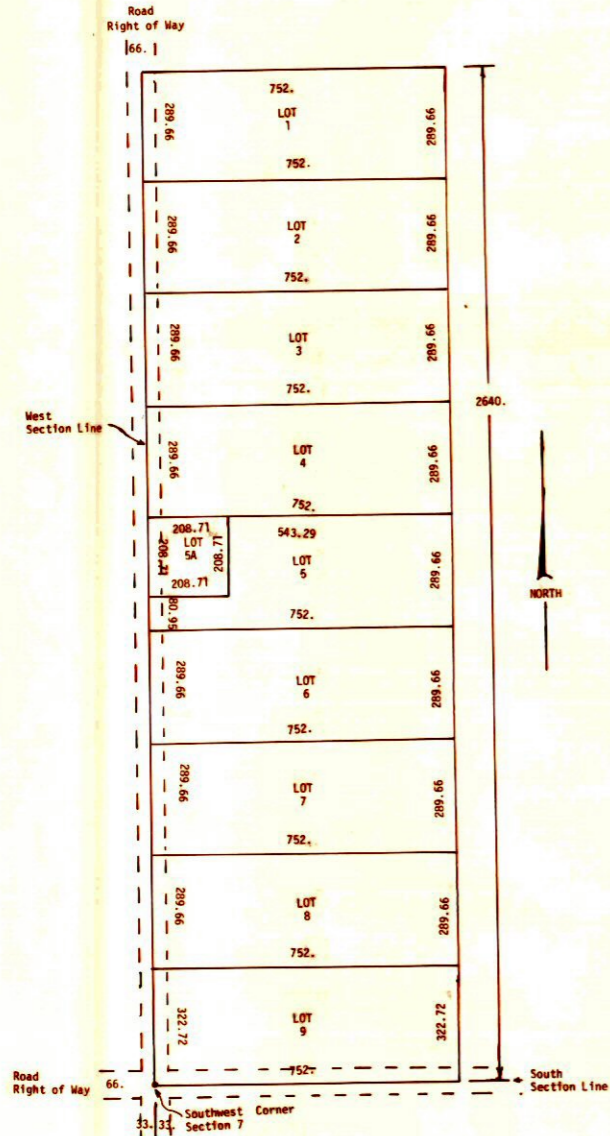


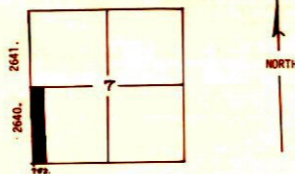
REMPE ACRES
