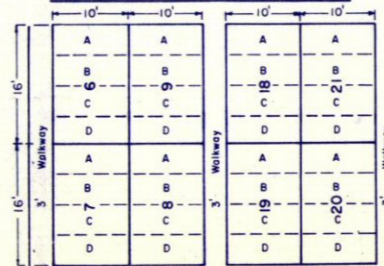
DETAIL

LEGAL DESCRIPTION

A TRACT OF LAND LYING IN AND BEING A PART OF THE NW 1/4 OF SECTION 2, TOWNSHIP 13 NORTH, RANGE 6 WEST, I.M., CANADIAN COUNTY, OKLAHOMA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS AS BEGINNING AT A POINT 50 FEET 89.98 FEET W FROM THE NE CORNER OF SAID NW 1/4; THENCE S 01° 48' 20" E, AND PARALLEL WITH THE EAST LINE OF SAID NW 1/4, A DISTANCE OF 83.00 FEET; THENCE N 89° 15' 26" E, AND PARALLEL WITH THE NORTH LINE OF SAID NW 1/4, A DISTANCE OF 50 FEET; TO THE EAST LINE OF SAID NW 1/4; THENCE S 01° 48' 20" E ALONG SAID EAST LINE A DISTANCE OF 2096.8 FEET TO THE NORTH RIGHT-OF-WAY LINE OF STATE HIGHWAY NUMBER 3; THENCE N 89° 08' 00" W ALONG SAID RIGHT-OF-WAY A DISTANCE OF 1054.65 FEET; THENCE CONTINUING ALONG SAID RIGHT-OF-WAY ON A CURVE TO THE LEFT HAVING A RADIUS OF 11,678.16 FEET, AN ARC LENGTH OF 390.98 FEET; THENCE N 65° 03' 00" W ALONG SAID RIGHT-OF-WAY A DISTANCE OF 391.89 FEET; THENCE N 57° 55' 34" W ALONG SAID RIGHT-OF-WAY A DISTANCE OF 201.56 FEET; THENCE N 65° 03' 00" W A DISTANCE OF 83.79 FEET; THENCE N 01° 57' 40" W A DISTANCE OF 1200.13 FEET TO A POINT ON THE NORTH LINE OF SAID NW 1/4, SAID POINT BEING 790.00 FEET EAST OF THE N.W.
