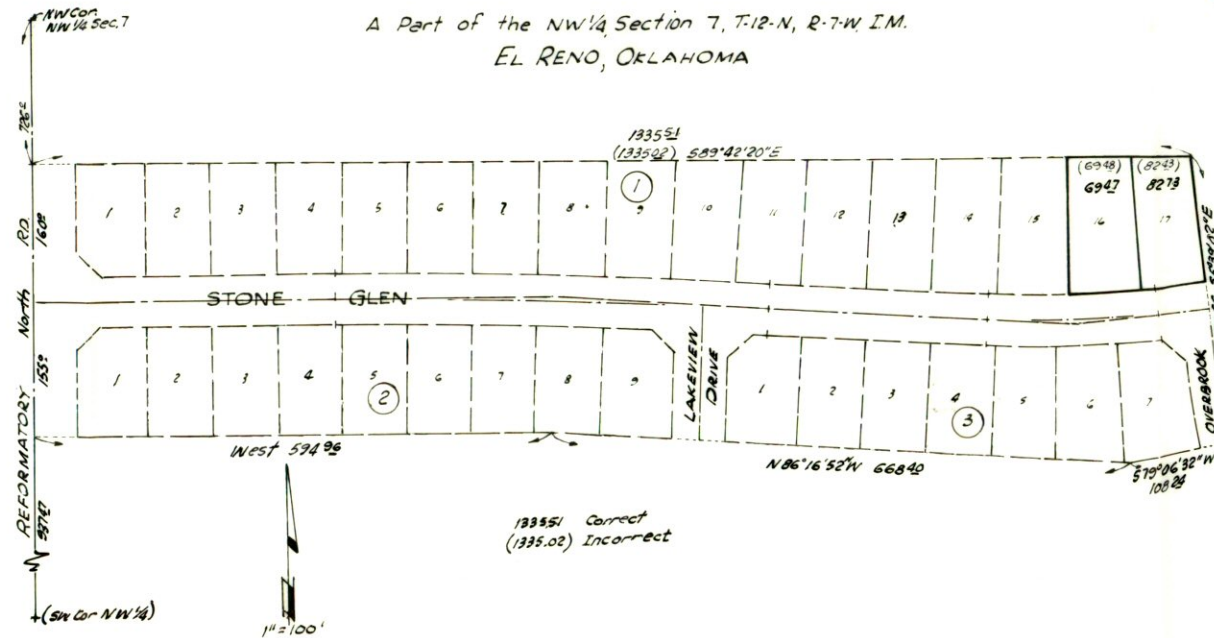

### SURVEYOR'S CERTIFICATE

I, WENDELL R. PHILLIPS, Registered Land Surveyor No. 370 in the State of Oklahoma, do hereby certify that I prepared the plat of STONE GLEN, an addition to the City of El Reno, Canadian County, Oklahoma, located in the Northwest Quarter (NW/4) of Section 7, Township 12 North, Range 7 West of the Indian Meridian, Canadian County, Oklahoma, and being more particularly described as follows:

Beginning at a point 726.00 feet South of the Northwest corner of said Northwest Quarter (NW/4) of Section 7; thence from said point of BEGINNING South 89°42'20" East a distance of 1335.51 feet; thence South 5°39'02" East a distance of 332.66 feet; thence South 79°06'32" West a distance of 108.24 feet; thence North 86°16'52" West a distance of 668.40 feet; thence West a distance of 594.96 feet to the West line of said NW/4 of Section 7; thence North along said West line a distance of 315.00 feet to the point or place of beginning; and containing 10.0732 Acres more or less.

I further certify that the above noted corrections were scribe's errors and by this Amended Plat are corrected: These being the North line of said Plat corrected to show 1335.51 feet; the North line of Lot 16, Block 1, to show 69.47 feet; the North line of Lot 17, Block 1, to show 82.73 feet; and the correct reference to the Northwest corner of said NW/4 a distance of 726.00 feet.
